BE IT FURTHER RESOLVED THAT all locals be encouraged to participate in the Young Workers' Committee (YWC) networks of their respective regions; and

BE IT FURTHER RESOLVED THAT the PSAC National Young Workers' Committee report back to the REVP(s) who hold the young worker portfolio.

Title: National Young Worker Conference

"Each Regional Young Workers Committee shall be entitled to elect (2) delegates;

Title: Young Worker Delegates at the Triennial PSAC National Convention

WHEREAS under our current delegate entitlement for the Triennial PSAC National Conventions, there are no delegate seats specifically allocated to young workers;

WHEREAS young workers are under represented at the PSAC National Convention; and

WHEREAS young workers are the future of every organization and the union and it is necessary to invest in and educate young workers; and

WHEREAS there is significant increase in the number of young workers we represent and the union is growing stronger; and

BE IT RESOLVED THAT each Young Workers Committee be entitled to a delegate at the PSAC National Convention;

BE IT FURTHER RESOLVED THAT Section 15 of the PSAC Constitution be amended to include the following;

"Sub section (7)

Young Worker Committees shall have the right to elect at a general membership meeting, held within a period of not more than twelve (12) months and not less than six (6) months prior to the commencement of the regular National Triennial Convention of the PSAC, a delegate to the forthcoming PSAC Convention".

TITLE: Climate change: PSAC Partnering with Tree Canada

efforts are a critical element in the fight against climate change to reduce air pollution, manage stormwater and provide shelter for wildlife.

Tree Canada is the only national tree planting charity in Canada. As a not-for-profit, registered charity, they are dedicated to improving the lives of Canadians by planting and nurturing trees in urban and rural environments while teaching about their value. By contributing towards Operation ReLeaf and National Greening programs, we can not only help communities across the nation recover from natural disasters, but also experience all the benefits that trees have to offer beyond capturing carbon and cleaning the air – trees in cities reduce noise pollution, cool our streets, and quiet our minds. The cost is approximately \$6.00 per tree.

WHEREAS since 2016 the Federal Government has increasingly filled numerous jobs traditionally occupied by PSAC members by consultants/contractors from various private companies.

WHEREAS the federal government is increasingly using contractors and consultants to perform the work of qualified PSAC members.

BE IT RESOLVED that the PSAC will lobby the Federal Government to employ PSAC members instead of contractors/consultants.

TITLE: Interim REVP

ORIGINATOR: PSAC-NCR Education Committee

LANGUAGE OF ORIGIN: English

WHEREAS there are no provisions in the PSAC Constitution to replace a Regional Executive Vice-President (REVP) while on paid leave;

WHEREAS the REVP for the National Capital Region (NCR) has been on leave and unable to fulfill their duties for more than eight (8) months – since May 2019;

WHEREAS this occurred during a crucial period of time, which included the 2019 Federal Election period and bargaining, where the REVP was not available to mobilize the members.

BE IT RESOLVED that Section 23 (10) of the PSAC Constitution be amended by adding:

In the event that the REVP is on leave and is unable to fulfill the duties of the office of the REVP for a period of over two (2) months, theses duties shall be fulfilled by the Alternate REVP from the same region once the REVP's absence has exceeded two (2) months.

BE IT FURTHER RESOLVED that in the event that the Alternate REVP is called upon to replace the REVP while the REVP is on leave, that the Alternate REVP shall receive the same pay and benefits as an REVP as per Regulation 17 of the PSAC Constitution.

TITLE: NCR Council meetings

ORIGINATOR: PSAC-NCR Education Committee

LANGUAGE OF ORIGIN: English

WHEREAS the PSAC-NCR Council (NCRC) meetings is filled with updates and reports that could be handled with other communication tools such as video conferencing;

WHEREAS the NCRC Executive is responsible for the issues arising between Conventions of the region;

WHEREAS this would represent a savings of approximately \$6,000/year. This does not include the cost of interpretation and technical services.

WHEREAS the money saved would allow the PSAC-NCR to organize other activities for members, such as multi-day training for members of regional committees.

BE IT RESOLVED THAT the PSAC-NCR Council Bylaws, section 7.1.2 be amended to read:

The PSAC NCRC shall meet twice per year, prior to meetings of the National Board of Directors (NBoD). A two-day Annual General Meeting (AGM) shall be included as one of these two meetings during the months of April, May or June.

Rationale:

Removing the obligation to meet 3 times a year will give the council more flexibility with its funds and allow it to organize other types of gatherings or training opportunities throughout the year.

TITLE: Special Meetings of the PSAC-NCR Council

ORIGINATOR: PSAC-NCR Education Committee

LANGUAGE OF ORIGIN: English

WHEREAS the By-Laws as currently written could make it challenging to convene special meetings of the PSAC-NCR Council

BE IT RESOLVED THAT the PSAC-NCR Council Bylaws, section 7.1.3 be amended to read:

Special meetings of the PSAC NCRC shall be convened if 10% of Council members so signify their wish by petition to the NCRC Executive. The NCRC Executive may also convene up to two (2) special meetings per year.

Rationale:

This will allow more flexibility in convening special meetings of the PSAC NCR Council if deemed necessary.

TITLE: Training for NCRC Committee/Council Members

ORIGINATOR: PSAC-NCR Education Committee

LANGUAGE OF ORIGIN: English

WHEREAS current training opportunities for PSAC-NCR Council (NCRC) committees / councils is scattered throughout the PSAC-NCR Education Schedule

WHEREAS members of NCRC committees/councils would benefit from a focused training that is geared specifically towards their needs

WHEREAS this would also provide an opportunity for members of NCRC committees/councils to network, exchange ideas on best practices and work together on campaigns or projects

BE IT RESOLVED THAT the PSAC-NCR offer a training of a duration of up to two days that is offered jointly to all NCRC committees and councils.

BE IT RESOLVED THAT this training is offered at least once every two years

BE IT RESOLVED THAT committees and councils be consulted in the choice of topics to be covered in this training in order to adequately meet their needs.

BE IT FURHTER RESOLVED THAT topics such as strategic campaigning, leadership skills and facilitation skills be considered for this training

TITLE: Homelessness Donation

ORIGINATOR: PSAC-NCR Education Committee

LANGUAGE OF ORIGIN: English

WHEREAS many Canadians are now facing to choose how to spend their limited income on Shelter, Food, and/or Medications. Homeless Shelters in Canada are now in demand more than ever before. This is becoming a responsibility of all, and a burden to struggling communities.

BE IT RESOLVED THAT the PSAC NRC makes a donation of \$5,000 to be divided between four (4) organizations that provide support to the homeless.

BE IT FURTHER RESOLVED THAT the NCRC Executive chooses the four organizations to receive donations that would be two in Gatineau and two in Ottawa.

TITLE: Create an Ottawa Universal Childcare Coalition.

ORIGINATOR: PSAC-NCR Education Committee

LANGUAGE OF ORIGIN: English

WHEREAS according to the 2008 UNICEF report, the Canadian childcare system ranked 25th among the OEDC countries. Other regions have an Universal Childcare Coalition. Ottawa as the Capital of Canada, should lead by example.

WHEREAS quality childcare is lacking in Canada to the point where only 1 in 4 children has access to regulated childcare. Creating this coalition will assist in this Region to obtain better Childcare. Also, help force the government to take action, and move forward on creating an Universal Childcare for all Canadians.

WHEREAS for every year a woman provides childcare to her child at home, she loses 5% of her earning capacity which she will never be able to regain in her lifetime. As a Union we should be promoting to achieve a gender balance. This not only contributes to children growing up to be happy, healthy and productive citizens but reduces the numbers living in poverty.

BE IT RESOLVED THAT the PSAC NCR will assist with the creation of an Ottawa Universal Childcare Coalition.

BE IT FURTHER RESOLVED THAT that PSAC NCR promote awareness of said Coalition Childcare with PSAC-NCR members and encourage members to participate in the implementation of the coalition.

TITLE: Promote Every Canadian Counts' efforts to establish a National Disabilities Program.

LANGUAGE OF ORIGIN: English

WHEREAS persons with long-term, chronic disabilities have to reapply for support services as they transition from one stage of life to another, such as childhood to adulthood; leading to periods of no coverage.

WHEREAS the Regional Executive Vice-President (REVP) for the National Capital Region (NCR) has been on leave and unable to fulfill the duties of the office of the REVP for more than six (6) months – since May 2019, and that this occurred during the 2019 federal election period.

BE IT RESOLVED THAT the PSAC Constitution Section 23 (10) be amended by adding:

In the event that the REVP is on leave and is unable to fulfill the duties of the office of the REVP for a period of over three (3) months, theses duties shall be fulfilled by the Alternate REVP from the same region once the REVP's absence has exceeded three (3) months.

BE IT FURTHER RESOLVED THAT the PSAC Constitution Section 23 (10) be amended by adding:

In the event that the Alternate REVP is called upon to replace the REVP while the REVP is on leave, that the Alternate REVP shall receive the same pay and benefits as an REVP as per Regulation 17 of the PSAC Constitution.

TITLE: Inclusion of Digital Communication Methods

ORIGINATOR: PSAC-NCR Communications Committee

LANGUAGE OF ORIGIN: English

WHEREAS the digital age has improved communication options and capacity; and

WHEREAS members of varying abilities might experience barriers to inperson participation; and

WHEREAS the PSAC Locals have members coast-to-coast-to-coast and abroad; and

WHEREAS members are often from remote posts who are unable to attend in person for various reasons;

BE IT RESOLVED THAT the PSAC include digital voting in the business of our union to ensure equitable access and participation; and

BE IT FURTHER RESOLVED THAT the PSAC include digital participation in the business of our union to ensure equitable access and participation.
