What went well?

- A male ally was elected REVP and women were elected Alternate REVP and Treasurer

Points for discussion

Ŷ	Some observers felt they were treated as second class members compared to delegates; although observers can't have voice or vote, they should receive
Ŷ	equal swag There is an opportunity for succession planning that ensures mentorship for
Ŷ	future transitions, such as REVP mentoring A/REVP Leadership training for sisters would help us build on strengths and achieve
Ť	shared objectives
	We could benefit from formalized Leadership Training, such as 'living in strength' by Gallup or OMFG initiative to increase female participation at all levels of leadership, women at work, CLC summer school; etc.

Report on child care	
Ŷ	In late 2016, PSAC put out a call for women living in Ontario who were interested in participating in consultations on child care. Government of Ontario released their report (see http://www.edu.gov.on.ca/childcare/eycc_action_plan.html). The policy addresses many of our concerns. Highlights include 45,000 new spaces to be created over the next 5 years, 100,000 new spaces created by 2022, \$1.6 B to be invested, and more than \$200 M earmarked for 2017
Terms of Reference	
₽	Some have raised concerns that ORWC is not inclusive as it excludes males. Discussion of need to maintain this safe space for women, and of need to clarify Terms of Reference. Consensus is that there is a need to review and update ToRs; Anne-Marie will send out an email call for volunteers
Health Care Coverage (Contraceptives)	
-	Current Public Service Health Care Plan only covers oral contraceptives (the pill). Discussion that the policy is dated and discriminatory as it adversely affects women who may have medical or personal reasons for choosing other forms of contraception. ORWC would like to submit a resolution to PSAC to advocate for non-oral contraceptives to be included in the PSHCP Final resolution due to OAC by August 1, should be prepared by mid-July Cherie offered to draft resolution, will need a volunteer to present at OAC
