## **H&S Training**

A one day training course was provided that included a session from Jeff Benny about the changes to the *Canada Labour Code*.

The four day WHSC course was postponed until after the course can be updated with the new legislation.

On February 21 & 22 there will be a French two day course "fighting for our lives". It will outline the changes to the Canada Labour Code imposed as part of bill C-4.

#### **Council Meetings**

All locals are encouraged to send representatives to the NCR Regional Council meeting January 25, 2014. The NCR Regional Council convention will be in May. If anyone has proposals for health and safety resolutions that they would like submitted to the PSAC convention, they have to bring the resolutions to the next regional health and safety meeting.

#### **Stand up to Defend our Rights**

There will be a meeting on January 18, 2014 to help members stand up for their rights.

#### **Varia**

There was a discussion on employers recognizing employees' activities on health and safety committees. Employers can recognize the activities of union activists, including health and safety activists on evaluations etc. Knowledge and experience gained on these activities can be added to CV's and used when evaluating employees in staffing actions.

Section 135.1(11) of the Canada Labour Code says that employees shall be compensated at their regular rate of pay for committee activities.

Training is very important to H&S activists. Unfortunately there is not a consistent level of high quality training being delivered. Activists can refer to the activities of other workplaces as well as Employment and Social Development Canada.
