#### **Meeting Called to Order**

The meeting was called to order by Co-Chair Zelma Buckley at 6:05 PM

#### Adoption of the Agenda

Motion to adopt the Agenda as amended was moved by Paulette Barker and seconded by Carl Laguerre; **the motion was carried.** 

# Adoption of the Annual General Meeting (AGM) Minutes

Motion to adopt the minutes of the 2016 AGM (for all those who were in attendance) was moved by Carl Laguerre and seconded by Behiye Cinkilic. All in favour – **Motion carried** 

#### Business arising from the previous Minutes:

#### Questions:

- 1. Are the 2016 activities items that are always carried out response: Mostly.
- Page 2 briefing by Larry in regards to NCR budget and the cuts imposed on the regional committees' budget – will we have cuts? Response (Larry): No cuts this year or next as the budget was a three (3) year plan. Regional budgets are allocated into 2018. In January 2019 the Council (Finance Committee) will decided the amounts that will be received by the regions.

#### Adoption of Executive Reports

#### a. Executive Summary report:

Motion was moved by Zelma Buckley for the acceptance of the Executive Report, this was seconded by Paulette Barker. Vote: 6 in favour, none against. Motion was carried

#### b. Financial Report:

**Motion** was moved by Paulette Barker for the acceptance of the financial report; this was seconded by Hayley Millington-Moustache. – 11 in favour, **motion carried.** 

#### c. RVAC Budget: Paulette Barker spoke to the 2017 budget.

Behiye Cinkilic raised a motion to set aside \$200.00 for the clergy Imam from the community outreach budget as last year the request came late and was denied. This will ensure that if he does ask the funds will be there.

Much discussion occurred around the following:

- It was thought that it would be better to do something for the Muslim community rather than being specific – other issues may arise;
- background was asked to be provided, Behiye Cinkilic provided the background information;
- we need to go back to our mandate to determine where our priorities are- all ethnic groups are not at the table;

- can miscellaneous be called something else such as community answer we already have a community section;
- some of the events re-occur each year- could we look into supporting other community groups. The motion was seconded by Carl Laguerre. Eight (8) were in favour of the motion, one (1) against and 2 abstained. Motion Carried
- question raised: since this group has the largest representation our food budget is higher than most, is potluck an option. - Answer: No: with people coming from work and different dietary requirements it is not a good idea.

**Motion** was raised by Carl Laguerre to move \$500 from Human Rights Day to Community Outreach – seconded by Dahabo Ahmed Omer. Eleven (11) in favour, 0 against - **motion carried.** 

Paulette Barker Moved the motion to adopt the budged as amended, seconded by Debbie Thomas. 12 in Favour, 0 against. Motion Carried
