#### 6) Review of the updated 3-year plan and fall schedule:

- a) What we have not done and want to move to the fall schedule:
  - Organizing virtual event postponed for now (on ice for now) until there is capacity & resources to offer this course. Anna Bogdan suggest to speak to Shawn from the Communications Committee.
  - ii) Union leadership clinic: relaunching the series in winter 2018 next year for this year it was a pilot project. The format that was tested was Monday nights and was well received. The Committee recommends that this delivery formula be adopted. The selection process should be done via the PSAC Regional level for transparency purposes. The selection process will be implemented for this is advanced training.
  - iii) Facilitating workplace Lunch and learn: Christine proposes that the committee create a task based meeting to develop this product. Chantal proposes that this be postponed until the Fall the new education officer has been hired. AFTP p. 5: Change facilitating to building
  - iv) Advanced Health & Safety postponed to fall 2017.

    - (2) Once the education officer is hired, Chantal will look into this with the officer. A working group has been created to organize this: Diane, Christine, Chantal, Louise, Behiye, Lee, Frederica, Anna, Grace
  - vi) Disability insurance only when we have capacity building we we look at this?
  - vii) The art of argument leave it up to the stewards' network to decide Grace to follow up with Corey Beauregard
  - viii) Health & Safety Basics when to offer: Louise to follow up with Sylvie Leblanc (alternate co-chair for PSAC Health & Safety Committee)
  - ix) Understanding and interpreting the collective agreement: add to fall of 2017 and winter 2018
