1. Special ENAP Presentation from Linda Boudreau

Linda presented an overview of the French Education programs (post-graduate studies) offered for Public Servants at their Hull location.

2. Elections

Given the newly passed Resolution at the PSAC Triennial, about delegates on committees, there was a discussion on how to proceed and there was consensus that we continue to follow the old rules for elections until such a time as the REVP shares the new processes to follow.

7. Update and discussion on retreat

- The committee was advised that having the retreat in-residence in Morrisburg location would not be a possibility. The committee voted by majority to have the retreat in-residence whichever option is cheaper and available will be selected by the PSAC. Chantal will send an email to Committee members once the information is available.

- It was suggested to do some preliminary work prior to arriving to the retreat in preparation to the retreat.
