PART 1: ACTIVITIES AND REGIONAL PRIORITIES

Regional Council – Activities, Successes and Objectives

- The Regional Executive met on August 4 and October 5 virtually and discussed:
- Treasury Board and agency negotiations and ratification votes
- Panel on bargaining with PA, TC, and CRA team members
- Updates from the REVP and Treasurer
- Group discussions on ways to engage with members in times of social distancing
- Ongoing discussions & updates on activities and news in the region

Regional Activities and Successes:

- 60 Treasury Board ratification information sessions were held between August 24 September 29.
- PSAC-NCR worked with the Prairie Region to win federal assistance for national museums during the pandemic.
- Regional Committees are finding ways to continue to meet virtually.
- The Racially Visible Action Committee has recruited many new members. The committee also issued a press release and participated in the Black Lives Matter march in memory of George Floyd June 5.
- The Young Workers Committee volunteered for the Ottawa Food Bank Community Harvest Farm and also initiated a digital recruitment ad campaign for Facebook.
- The REVP met with representatives from the Workers History
 Museum to support the production of a documentary on the case that
 established marriage equality rights for federal workers involving
 PSAC-CEIU member Dale Akerstrom. A motion was brought to the

- AEC for \$10,000 in funding to support the Museum's ongoing work. PSAC-NCR and the NCR Pride Committee also contributed \$1500 regionally to WHM projects.
- PSAC-NCR and the PSAC-NCR Pride Committee participated in this year's Capital Pride Virtual Parade by submitting a video & picture montage of PSAC-NCR at Capital Pride events over the years.
- REVP submitted a video message in the Ottawa and District Labour Council Virtual Labour Day Parade.

Regional offices

• The Regional offices continue to work from home serving members. There is no return to work date set and the management team is looking into a gradual return to work strategy and a safety plan.

- Our net followers grew by 3% since the last quarter

 The Conseil Régionale d'Action Politique de l'Outaouais area council organized an action outside MP Stéphane Lauzon's office in Buckingham QC to ask that he supports PSAC's call to get the Treasury Board and CRA back to the bargaining table.

Campaigns

Les Terrasses de la Chaudière: For a Healthy Workplace

 The REVP and UNE National Executive Vice-President Andrew Shaver met with the Assistant Deputy Minister for PSPC Real Properties Stéphan Déry to talk about work being done to address health & safety concerns at LTDC and next steps. Discussions have been positive and updates have been communicated as work proceeds.

Hard Rock Casino:

- On March 15th, members of UNE Local 71201, working at the Hardrock Rideau-Carleton Casino received notice from the employer of the casino will shut down on Monday, March 16 due to the COVID-19 pandemic and workers would be laid off. A landing page was created with an online email tool to send letters to the employer in support of the workers with over 400 letters sent. Communication with the local and the employer is ongoing.
- Working on a landing page to launch that collects contact info of members to help mobilize for bargaining.

Collective Bargaining and Ratification in the Region

- Salvation Army Preparing for bargaining
- St. Paul University Bargaining commenced. Employer cites the Ford government's Bill 124 as a barrier to making major improvements.
- Nordion & BWXT

 Notice to bargain sent to employer, bargaining team elected, parties met May 21 and finalized the bargaining unit description.
- NAC Bargaining, new virtual dates have not been announced.
- House of Commons Operational Group and Postal Services Sub-Group served notice to bargain.

- Senate of Canada Operational Group in bargaining.
- Museum of Nature bargaining underway, COVID required bargaining no-layoff MOU's, bargaining expected to resume in the fall.
- Parliamentary Protective Services Employer plans to make changes to classification system.
- Museums of Science & Tech, Aviation and Agriculture NCR also reached a new MOU with the employer that included a "no layoff" clause and provides all employees with two additional personal days.

- SSHRC Pre-bargaining session cancelled due to shut down, negotiations on hold until PA group addressed
