## 1. Adoption of the agenda, as amended:

## 2. Joint project with Droits Diversité Dialogue

- Johanne Labine, former REO, is part of an organization seeking to engage the community in a dialogue to promote inclusion and anti-racism given the Islamophobic rhetoric in Canada and, in Quebec with the adoption of Bill 21. The activity aims to have 30-40 participants from the members of the community and the PSAC.
- The group Droits Diversité Dialogue is seeking a partnership with the PSAC-NCR and are asking that the Education Program pay for the room rental and beverages: a cost of approximately \$320.

- Modified TORs will be presented at a subsequent committee meeting for discussion and adoption.
- Should the Committee adopt TORs to include a 2<sup>nd</sup> vice-chairperson, elections will need to be held to fill the newly created position.

# 5. Follow-up on items from previous meetings:

- Facilitator training:
  - Pierre got the go-ahead to modify the Alliance Facilitator Training Program (AFTP) to remove references to Alliance Facilitator (AF) or AFPT.
  - o It is the hope of the committee this training can be offered at fall 2020.
- Education Registration form:
  - o No change. We are waiting for the PSAC-NCR website redesign.
- Training on strategies for implementing a violence prevention program in the workplace:
  - No change. This is in the hands of the National Health and Safety Advisors (A. Pert & D. St-Jean). It was likely delayed by the planning of the National Health and Safety Conference in December 2019.
- Women in politics:
  - A working group consisting of Chantal Fortin, Carla Ross and Anna-Marie
    Melanson met in December and sent a proposed agenda to Pierre.
  - Chantal indicated that she will send a copy to Committee Members.
- Resolutions forwarded by the Education Committee:
  - Chantal indicated that the Resolutions Committee met and provided a summary of the discussions. Also, two of the resolutions were deemed out of order by the Office of the National President.

# 6. Education Program Update:

- Registrations are up overall
- TUB/ABC and Duty to Accommodate are very popular
- Grievance Handling is full



- Need to promote the following courses:
  - Caring for the Labour Activist
  - o Advanced Health and Safety
- Paperless course ABC du Syndicat (French TUB) was offered members were very satisfied with the new format.
- Some members inquired about popular courses such as TUB or Grievance
   Handling. Locals should contact their regional representative at the PSAC-NCR
   office to help coordinate. There may be a possibility to offer to multiple locals.

## 7. Leadership clinics:

- These were several evening modules that were last offered approximately once a month, over several months starting in June 2017
- It was very popular and well received by members who attended
- There is an interest from the committee to offer leadership clinics again
- Lee and Alex will look at the content of the previous clinics and come back to the committee with recommendations and a way to include a role for mentors.

#### 8. Motions:

#### Motion #1

- Sending an observer to the PSAC-NCR Convention will increase the visibility of the Committee. The observer will also be able to lobby members on resolutions submitted by the Education Committee and promote the Education Program in the common areas on behalf of the Committee.
- Motion: The Education Committee will send an observer to the 2020 PSAC-NCR Triennial Convention. The Committee will pay the registration fee, reimburse loss of salary for the Friday, will pay an allowance for lunch and incidentals for the three days, and will provide reimbursement for transportation.
